

Declaration of Conformity – EU REACH Regulation

This is to certify that Riedel Communications Canada Inc. products, to the best of its knowledge, conform to requirements of EU Directive (EC 1907/2006) of the European Parliament, "Registration, Evaluation, and Authorization of Chemicals (REACH)."

These products are defined as <u>articles</u> per Article 3.3 of the REACH Regulation: "Article: means an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition." Additionally, the referenced models do not intentionally release any substances.

Riedel Communications Canada products/article do not contain any of the Substances of Very High Concern (SVHC) candidates listed, above the regulatory threshold of 0.1% in our products/article nor does Riedel Communications Canada tonnage exceed 1 ton per importer per year. Therefore, the requirement in REACH to notify ECHA of products/articles exceeding these limits is not applicable.

Riedel Communications Canada European operations do not manufacture or import chemicals; therefore, Riedel Communications Canada is not required to register substances.
